

Notice of Newly Enacted Ordinance

Please take notice that the Village Board of Weston, Wisconsin enacted on December 7, 2015, Ordinance No. 15-029: An Ordinance Amending Section 82.107(a) of the Municipal Code of Ordinances Entitled *Winter Parking Regulated*.

Per Sec. 82.107 (a) *Winter Parking Regulated*. When signs have been erected at or reasonably near the village limits as provided in §349.13, Wis. Stats., alternate side parking shall be in effect on all streets between the hours of 4:00 a.m. and 4:00 p.m. of any day, from October 31 to May 1. All vehicles shall be parked only on the even-numbered side of the street on even-numbered calendar days, and only on the odd side of the street on odd-numbered calendar days, unless otherwise posted or exempted. No person shall park, stop, or leave standing, any vehicle in violation of this subsection.

ORDINANCE NO. 15-029

AN ORDINANCE AMENDING SECTION 82.107(a) OF THE MUNICIPAL CODE OF ORDINANCES ENTITLED *WINTER PARKING REGULATED*.

WHEREAS, Chapter 82 of the Weston Municipal Code provides for regulations and enforcement procedures for traffic and vehicular operation within the Village; and

WHEREAS, from time to time, Municipal Ordinances should be reviewed and amended to ensure the ordinances are still relevant and up to date; and

WHEREAS, nighttime parking on streets in the Village during winter months can cause issues with traffic safety and can at times effect the ability of Village Street Crew Personnel to properly clear the streets of ice and snow on a timely manner; and

WHEREAS, it has been determined an amendment to the nighttime parking ordinance would assist with making streets safer during the winter months; and

NOW, THEREFORE, the Village Board of Weston, Marathon County, Wisconsin, do ordain as follows:

SECTION 1: Section 82.107(a) of the Village Of Weston Municipal Code of Ordinances entitled *All-night parking regulated* is hereby amended to provide as follows:

Sec. 82.107. Parking regulations.

- (a) ~~*All-night Winter parking regulated.*~~ When signs have been erected at or reasonably near the village limits as provided in Wis. Stat. § 349.13, ~~no person shall park any vehicle for a period of time longer than 30 minutes~~ alternate side parking shall be in effect on all streets between the hours of 24:00 a.m. and 64:00 ap.m. of any day; from October 31 to May 1; All vehicles shall be parked only on the even-numbered side of the street on even-numbered calendar days, and only on the odd side of the street on odd-numbered calendar days, unless otherwise posted or exempted. No person shall park, stop, or leave standing any vehicle in violation of this subsection. except physicians or surgeons, when parking is reasonably necessary on emergency calls.


SECTION 2: SEVERABILITY. If any section, clause, provision, or portion of this Ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby. If an application of this Ordinance to a particular structure, land, or water is adjudged unconstitutional or invalid by a court of competent jurisdiction, such judgment shall not be applicable to any other structure, land, or water not specifically included in said judgment. If any requirement or limitation attached to an authorization given under this Ordinance is found invalid, it shall be presumed that the authorization would not have been granted without the requirement or limitation and, therefore, said authorization shall also be invalid. Any other ordinances

whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 3: EFFECTIVE DATE. This ordinance shall take effect upon approval and publication.
