





## ORDINANCE 16-049

### AN ORDINANCE TO REPLACE THE OFFICIAL MAP OF THE VILLAGE OF WESTON, MARATHON COUNTY, WISCONSIN.

WHEREAS, §62.23(6), Wis. Stats. authorizes each local government to adopt an Official Map to conserve and promote the public health, safety, convenience or general welfare by designating land for expanded and future highways, parkways, waterways, and other public facilities; and

WHEREAS, on February 15, 2016, the Village Board adopted an Official Map via Ordinance 16-002, but that its updated Village Comprehensive Plan in October 2016 and other changes warrant the update to and replacement of the February 2016 Official Map; and

WHEREAS, on September 21, 2016, the Plan Commission recommended Village Board adoption of the replacement Official Map in the form attached hereto as Exhibit A; and

WHEREAS, on December 19, 2016 the Village Board conducted a public hearing on a replacement Official Map, attached hereto as Exhibit A, pursuant to §62.23(6), Wis. Stats.; and


WHEREAS, the Village Board accepts the recommendation of the Plan Commission and has determined that the update of and replacement to the Official Map will promote the public health, safety, convenience, general welfare, and orderly development of the Village and its extraterritorial jurisdiction.

NOW, THEREFORE, BE IT RESOLVED THAT, the Village Board of Weston Wisconsin, does ordain as follows:

1. The map attached hereto as Exhibit A is established as the Official Map of the Village of Weston, pursuant to §62.23(6), Wis. Stats., replacing any and all official maps previously adopted by the Village.
2. The Village Clerk is directed to record with the Marathon County Register of Deeds a certificate showing that the Village has updated and replaced its Official Map, along with a copy of the newly updated Official Map.




## Future Transportation / Official Map



Pursuant to Section 62.23(6)(c) of the Wisconsin Statutes, notice is hereby given that the Board of Trustees of the Village of Weston will hold a public hearing on December 19, 2016, at 6:00 p.m., or as soon thereafter as possible, in the Board Room of the Weston Municipal Center, 5500 Schofield Avenue, Weston, WI, for all persons wishing to be heard on an Ordinance to replace the Official Map of the Village of Weston.

The public hearing will be held to gather public input on the replacement Official Map. The purpose of the Official Map is to show, to the extent possible, future highways and bypasses, other future arterial and collector streets, and suggested wider rights-of-way for some existing major streets. The Official Map also shows other future public facilities where their location is known or critical, such as major components of the planned regional stormwater management system. No permit may be issued to construct or enlarge any building within the limits of any street, highway, waterway, railroad right-of-way, public transit facility or parkway, shown or laid out on the Map except as provided in Section 62.23(6) of the Wisconsin Statutes.


