VILLAGE OF WESTON, MARATHON COUNTY, WISCONSIN AN ORDINANCE
AMENDING ARTICLE II., VILLAGE BOARD, SECTION 2.207 AND
COMMITTEES, SECTION 2.215 RELATING TO MEETINGS AND
COMMITTEE OF THE WHOLE OF THE MUNICIPAL CODE FOR THE
VILLAGE OF WESTON, MARATHON COUNTY, WISCONSIN

The Village Board of the Village of Weston, Marathon County, Wisconsin, do ordain as follows:

SECTION 1: Article II, Sections 2.207 Village Board Meetings, and Section 2.215 Committee of the Whole of the Village of Weston Municipal Code is hereby created as follows:

Article II. VILLAGE BOARD

Sec. 2.207 Regular meetings.

~~Unless otherwise set by resolution of the board, The regular meetings of the board shall be held at the municipal center on the first and third Monday, of each month at 6:00 p.m.; except that when the day for holding any regular meeting shall be a legal holiday or election day, the regular meeting shall be held at the same time and place on the next following secular day, or on a date and time as set by the board at a regular meeting in advance of the holiday. Any regular meeting falling on a legal holiday shall be rescheduled at the preceding meeting.~~

Sec. 2.215. Committee of the whole.

~~The president may call for a meeting of the entire board as a declare the entire board a committee of the whole for informal discussion at any meeting or for any other purpose on any matter. The president and shall ex-officio be the chairperson of the committee of the whole of the same.~~

SECTION 2: SEVERABILITY. If any section, clause, provision, or portion of this Ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

SECTION 3: SECTION 4: EFFECTIVE DATE. This ordinance shall take effect upon approval and publication.


