RESOLUTION NO. 2017-011**

---

- A RESOLUTION,** requesting the Village of Rothschild and City of Schofield rename E. Grand, W. Grand and N. Grand Avenue in their communities as part of the Marathon County Uniform Addressing Project.
- WHEREAS,** the Village is participating in the Marathon County Uniform Addressing Project and thus have been notified by Marathon County of a list of duplicate and non-contiguous streets in the Village which will need to be renamed.
- WHEREAS,** Marathon County has suggested communities work with neighboring municipalities to rename confusing and duplicate street names in the communities.
- WHEREAS,** as part of this process, it was determined the Trustees have a desire to also rename a few streets within the Village which are confusing and do not make sense to visitors and residents traveling the street.
- WHEREAS,** one of these streets is Schofield Avenue and it is suggested to be renamed to Grand Avenue as it is contiguous with Grand Avenue coming from Wausau.
- WHEREAS,** Exhibit A shows the current layout of the existing Grand Avenue, Schofield Avenue and N., W., and E. Grand Avenues in the three communities.
- WHEREAS,** Exhibit B shows the proposal of name changes requested by the Village.
- BE IT RESOLVED** by the Board of Trustee for the Village of Weston hereby request the City of Schofield rename S. and W. Grand Avenue to Schofield Avenue to allow for Schofield Avenue in the Village of Weston to be renamed to Grand Avenue.
- BE IT FURTHER RESOLVED** that the Trustees request the Village of Rothschild rename E. Grand Avenue to Rothschild Road or Street.

**QUESTION:**

Should the BOT approve Resolution No 2017-011 requesting Rothschild and Schofield rename E., W. & N. Grand Avenues in their communities so that Weston can rename Schofield Avenue to Grand Avenue as it is a logical extension of Grand Avenue coming out of the City of Wausau.

---

**BRIEF:**

The Village, in 2015, pledged support and participation in the County Uniform Addressing Project and therefore will be readdressing all parcels in the Village and renaming duplicate street names. The Board has requested Schofield Avenue be renamed. Staff feels it would be logical to rename to Grand Avenue as it extends out from the City of Wausau. We could then give the name "Schofield Avenue" to Schofield as it will run through the middle of their community and Rothschild could then rename their portion to "Rothschild" St or Rd (which is shown on old platting maps staff found).
