- WHEREAS,** the Village Board has determined the fee of \$100.00 be set forth in the amended fee schedule as it is appropriate and reasonably approximate to the Village's basic costs in providing the review of a permit for parking lot reconstruction or resurfacing/resealing as described in Section 94.12.09(2).

**BRIEF:**
